User's Manual

Features:

1. Dual socket output for 12-24VDC
2. Battery recharger for two AA Ni-Cad or Ni-MH batteries
3. Built-in map light for illumination
4. LED battery indicator

Power Source:

1. DC 12V-24V
2. Two rechargeable AA batteries

Power Consumption For Map Light :

- Voltage: 2.3V
- Current: 0.25A
- 8 hours continuous usage

Operational Instructions:

Socket output

- Plug this unit in the cigarette lighter socket until the green LED light is on, then both sockets will be ready to use for 12-24 Volts power source. At this time, the flashlight can be turned on for illumination by pressing the button (located in the back of the flash light)

Battery charger

- The LED light will turn red when two weak or dead batteries are installed during the status of recharging. It will charge the batteries in the maximum output current of 800mA. Normally, the capacity of 1200mAh Ni-MH batteries can be charged up to 80% within 40 to 60 minutes, and the LED light should turn green. The batteries can be fully charged at the later time
- Two fully charged batteries should last at least two hours for continuous illumination

Care

- The light bulb can be screwed off for replacement
- Even any normal alkaline battery can be used for illumination, but we strongly recommend rechargeable batteries should always be considered at all time
- Always charge the batteries immediately when batteries are getting weak
- Never use regular alkaline batteries in this unit, or any unexpected explosions may result in personal injuries or property damages
- When a sign of weak batteries constantly detected after a short period of use, please replace these batteries since they are limited for usage
